

Bulk Order Types

The bulk order types listed below will use the format detailed in the following sections:

1. Daily Filing Update/Replacement (Subscription)
2. Daily Filing Update/Replacement (One-Time Request)
3. Master Unload (New Master Unload)
4. Master Unload (Previous Master Unload)
5. File Layout For Daily Filing Update/Replacement
6. File Layout For Master Unload

For bulk orders of types 1 through 4, the file format is detailed in the following sections.

Bulk Order file generation and file formats

For bulk orders of type 1 and 2, a file is generated on a daily basis. Files are put in a specified directory on the server and are made available to clients with active subscriptions or active bulk orders (in case of type 2). For bulk orders of type 3 and 4, a file is generated on the first Saturday of each month in the same directory as for types 1 and 2. The file name format is detailed below.

The files generated are text files and contain record codes at the start position to indicate the type of record. These record codes are:

- Record Code 4. Organization Secured Party File
- Record Code 5. Individual Secured Party File
- Record Code 6. Amendment File
- Record Code 7. Collateral Data
- Record Code 9. Trailer Record

Each record has a length of 506 characters and all the fields contained within are fixed-width strings with space filled on the right to make up for the assigned width. The following tables describe the record code formats:
